London calling to study

It's not too late to join the trip of a lifetime. Studying in London is only a hop, skip and less than seven months away. Students have until May 5 to turn in applications.

Los Rios Community College District and various others have teamed up to give any student a chance to study abroad, in London, for fall semester, Sept. 10 through Dec. 12.

Patrice Gibson, Anthropology professor and co-director of the ACE program and faculty member of American River College was selected to accompany students to London along with four other professors from various community colleges.

Gibson says the only requirements to qualify for the program are the applicants must be college students, have a minimum 2.5 GPA and have completed 12 units by summer 2008. Students, also are required to take 12 transferable units while in London.

Students will only attend school four days a week for 12 weeks as opposed to the 16 weeks in the Los Rios district. They also will be given the option of living in an off-campus apartment, or with a British family.

"I think we are all going to get so much out of this [program]. It's important to learn different culture and to experience [different culture]," said Gibson.

The cost of this three and a half month experience

is around \$9,000, but this includes airfare, tuition, the program, and a refundable deposit. Students also have the opportunity to apply for financial aid. Gibson says it is worth it.

"Even though it seems like a lot of money, it's a truly priceless experience," said Gibson. "This is the time . . . when taking a semester will be easier now than later when [students] have careers and kids."

There will be an initial deposit of \$400 and a \$50 application fee. If students turn in their applications by March 28, they will have priority to pick out their classes. They also will be entered to win a Eurostar ticket which will take them from London to Paris.

An informational meeting is scheduled for today at 1:30 p.m. in Howard Hall conference room and another at 5 p.m. in Raef Hall room 162, and again on March 26 at 12 p.m. in Howard Hall conference room. An additional meeting will be March 12 from 3 p.m. to 5 p.m. in room M201 at Cosumnes River College.

Depending on the department involved or the outside activity, students may be asked or allowed to take their own vehicles, professionally driven bus or, on very rare occasions, a commercial airline. Unfortunately, students have no say in which kind of transportation to use.

Letter to the editor

As a Student Representative, I'd like to explain to my constituents what is going on inside the Student Council. On February 12, I, and 4 other council members, resigned. The following is my letter of resignation (with minor additions for clarity):

I am officially resigning from my position as Student Representative on the American River College Student Association, effective immediately.

I am resigning in protest of SA President Lou Martinson's un-ethical, and possibly illegal, abuse of power and usurpation of the student's right to elect their own representatives. On February 5, the Student Council voted on whether to fill three open council positions by appointment process or by upholding the student's right to elect their own representatives through a special election. According to the By-laws,

the student's right to vote through a special election is by default, but may be over-riden by a 2/3 vote of the Council. There would have been no 2/3 majority had President Lou Martinson not deceitfully denied the right of one of the Student Representative's to vote on over-riding the special election. By denying this Representative's pivotal vote, Martinson was able to over-ride the special election, thereby denying the students' fundamental right to elect their own representatives. This deceitful, un-ethical activity must never be tolerated in a democratic society. Having moved here from Russia where we had no freedom to participate in government, I strongly support the right of the people to vote and am deeply concerned to see such a disregard of this fundamental right by the SA President.
